PROFESSIONAL TRAINING

Core Correctional Practices (CCP) (End User), Fall 2014.

Core Correctional Practices is a two-day training that instructs correctional workers on the core skills needed to support cognitive behavioral programming. The training is relevant to direct care, security staff, and treatment staff. Specifically, CCP training focuses on integrating positive intervention strategies into correctional officers' daily routines and restructuring the cognitive abilities and the social skills of inmates.

Increasing Reproducibility Research Practices, Spring 2014.

The Center for Open Research hosted a 3-hour seminar focused on the practical steps young researchers can employ to increase the reproducibility of future research. Participants were introduced to Open Science Framework, a free online data management and sharing service hosted by The Center for Open Research.

Level of Service Inventory-Revised TM (LSI-RTM) (End User), Fall 2014.

The LSI-R survey, originally developed by D. A. Andrews, Ph.D., and James L. Bonta, Ph.D. relies upon a nationwide validated quantitative survey of offender attributes to determine the appropriate circumstances for future supervision and treatment. The 54-item survey concentrates upon 10 subsections of the offender's lifestyle. The training provided an overview of the LSI-RTM and techniques for administering and scoring the individual assessments. In addition, the training reviewed how to use the scores obtained from individual LSI-RTM assessments to develop case plans for reducing future offending

The Ohio Risk Assessment System (ORAS) (Trainer), Spring 2015.

The Ohio Risk Assessment System (ORAS) is a dynamic risk/needs assessment system to be used with adult offenders. It offers criminal justice actors the ability to assess individuals at various decision points across the criminal justice system. The training provided an overview of the various ORAS tools and techniques for administering and scoring the individual assessments. In addition, the training reviewed how to use the scores obtained from individual ORAS assessments to develop case plans for reducing offender risk.

Thinking for a Change (T4C) (End User), Fall 2015.

The T4C program is a cognitive-behavioral program developed by Jack Bush Ph.D., Barry Glick Ph.D., and Juliana Taymans Ph.D. The curriculum for the T4C program is built around the core principal that thinking controls behavior. The end user training is designed to prepare participants to facilitate T4C trainings within various correctional facilities.
